

Instructions: Enter the voucher code given out at the session. Log in to www.eventscribe.com/Magnet/FinExIA.htm to register and enter your codes (CODES MUST BE IN ALL CAPS). Your total credits will be calculated per field of study and you will be able to print out a certificate Please note that the proper calculation method for CE credits is total number of minutes PER FIELD OF STUDY, divided by 50 and **ROUNDED DOWN** to the nearest half credit. Thus, a 2 hour session counts for 2 credits (120 divided by 50 = 2.4, **ROUNDED DOWN** to 2.0 credits). For sessions in italics, you may claim only ONE. There is no longer a need to sign in or out at each session since the codes validate your participation. As such, in order to protect the integrity of the system, we cannot give out codes before or after the session ends. The maximum number of credits you can claim is 19.5. Sessions in italics are concurrent, therefore you can claim only one!
