EPA increases focus on Retailers

Increased Focus on Grocer/Retailer Waste

US EPA and certain states have been scrutinizing retailers on hazardous waste management:

- **Mishandling returned/damaged products**
- **Improper disposal** (dumpsters, drains)
- **Improper storage**
- **Improper shipping**
- Regulatory activity has been increasing in CA, TN, VA, WV, AZ and other states

Hazardous waste defined by category and type

What is Hazardous Waste?

- Dangerous or potentially harmful to health or environment
- Can be liquids, solids, or gases
- Can be commercial products; cleaning fluids or pesticides
- By-products of manufacturing processes





Hazardous Waste Categories

- **Hazardous by Characteristic**
 - Ignitable – Measured by Flashpoint under 140F
 - Corrosive – Measured by pH <2 or >12.5
 - Toxic – Measured by Testing
 - Reactive – Not Measurable – Defined by EPA
- **Hazardous by Listing**
 - Commercial Chemicals – P and U Lists
 - Waste from Specific Processes – K List
- **Universal Waste** – Light bulbs, batteries, pesticides

Hazardous Waste Generator Categories

Large Quantity: > 2,200 pounds per month or
> 2.2 pounds per month of acutely
hazardous waste

Small Quantity (SQG): Between 220 and 2,200
pounds per month

Conditionally-exempt (CESQG): < 220 pounds per
month.

**In most cases, grocery stores fall into this category.*

Universal Waste



- Fluorescent Lamps
- Batteries
- Mercury-containing devices
- Pesticides
- Universal Wastes are subject to less stringent regulations when recycled




Pharmacy Hazardous Waste

- Expired / Unused pharmaceutical products
- Residual pharmaceuticals:
 - *IV bags, tubing, vials, medication, inhalers, aerosols, etc.*
- Broken and dropped pills

Pharmacy Hazardous Waste

- Warfarin
- Coumadin
- Nicotine



- *These are considered acute hazardous wastes by EPA definition.*


Pharmacy Hazardous Waste

- Phentermine
- Epi Pens
- Inhalers (flammable aerosols)
- Chloral Hydrate



Pharmacy Hazardous Waste Containment

5-gallon locking buckets for Rx hazardous waste





Pharmacy Waste does not include:

- Blood
- Body tissue
- Body fluids
- Sharps

** These are medical / infectious wastes that require different disposal*

Hazardous Waste Requirements

- **Keep it Simple!**

- Have a written hazardous waste program
- Create a designated hazardous waste area
- Have a process for handling small spills






Hazardous Waste Do's

- Assign process ownership to a member of store management
- Contain leaking products in separate bags
- Segregate Incompatible Wastes
 - Flammable, Aerosol, Acid, Base, Bleach, Toxic
- Store waste stream in closed & labeled containers
- Maintain Shipping Papers
 - Manifests or Bills of Lading
 - Disposal Vendor can assist greatly
- Train appropriate personnel

HAZARDOUS MATERIALS KEY

These materials when damaged or spilled should be sorted into the following categories. Place items in the appropriately labeled totes until the product can be picked up by a licensed contractor. If you do not know what category a product belongs in, and the label does not help (check for signal words), call KCAC at 1-800-982-2749

Batteries (lead acid, ni-cad, silver) and bleach should be stored separately from other hazardous materials and from each other. Automotive batteries are picked up under another program and are stored separately from the hazmat containment area.

Signal words are: Poison, Danger, Warning, or Caution. They identify a product as hazardous.

Hazardous Materials Do Not Ship List

The products listed below *will not* be shipped by Store Associates.

- Denatured Alcohol • Acetone • Castrol Super Clean • Muriatic Acid
- Paint and Varnish Stripper • Matches • Lighters • Propane
- Coleman Fuel (Propane and Liquid Gas) • Lithium Batteries
- Lacquer Thinner • Plumbing Chemicals • Deck Stripper
- Truck Bed Coating Paint • Butane (includes all lighters) • Insecticides
- Fire Extinguishers • Automotive Products • Spa and Pool Chemicals • Fireworks



Hazardous products identified as Limited Quantity in the handheld units may be shipped when boxed and marked with this Limited Quantity label. Always follow Division Reclaim Policy.



STOP!

Before shipping any item, be sure you know if it is Hazardous.

Look for the Signal Words:

- Poison • Danger • Flammable • Warning •

Check the product to be shipped. If any of these signal words are on the package, label it as Limited Quantity before you ship it.

Never ship hazardous waste. Hazardous products and hazardous waste may never be disposed of with regular trash or poured down a drain. Licensed, approved contractors will remove hazardous waste on a regular basis. Waste disposal may be requested by contacting Kroger Central Alarm Control at 1-800-982-2749

Recycle and Reclaim

Materials are not hazardous wastes when they can be shown to be recycled:

- Used or reused as ingredients in an industrial process to make a product
- Used or reused as effective substitutes for commercial products..."

What to watch out for:

- Must put into process “as-is” to make a new product
- Documentation of process

Program challenges and training requirements



Hazardous Waste Challenges

- No process
- Limited knowledge
- Too many products
- Too many waste streams
- Identifying products that are hazardous
 - The generator's duty is to determine if their wastes are hazardous (Based on testing or process knowledge)
- Understanding when a hazardous product becomes a hazardous waste
- Training employees to manage hazardous waste



Employee Training

- Train Associates who have hazardous waste handling responsibilities:
 - Back Door Receivers
 - Store Managers
 - Asst. Managers
- Initial training upon hire
- Annual refresher training
